We invite you to participate in the Artisan Sale, which is the heart of the event and the main attraction.

Here are the guidelines for participation in the Artisan Sale:

- All work sold must be created by the artist.
- Booth fee is \$50.
- Available space for each artist will be the equivalent of one eight-foot table. We encourage artisans to bring their own display furniture that will fit in the space.
- Set-up time will be Friday, November 7 from 6:00 - 8:00 p.m. and Saturday, November 8 from 8:00 - 9:45 a.m.
- Takedown and cleanup must be accomplished by 6:00 p.m. on Saturday.

If you don't want an individual booth, and you're an Arts Center member, we have space for a limited number of member artisans at the Members' and Fiber Arts' tables. If you'd like to exhibit on either of these tables, you still need to fill out the enclosed form. Artisans without tax numbers must exhibit at the Members' or Fiber Arts' tables and be current members of the Arts Center. The fee for these artisans is \$25 for half of an 8-foot table.

Space is limited, so please get your response in promptly. There is no jury fee, but we may request images of your work prior to acceptance. You will be notified by e-mail if you are accepted to the fare.
