- Set-up time: Friday, November 3, 6:00 - 8:00 p.m. & Saturday, November 4, 8:00 - 9:45 a.m.
- Takedown and cleanup must be accomplished by 6:00 p.m. on Saturday.
- Again this year, we'll secure parking and shuttles for the artisans off-site to allow maximum shopper parking.
- WE WILL FIGURE OUT BETTER LIGHTING for this year! It was far too dim last year. We are working on a solution.
